



## CONSENT TO PROCESS PERSONAL DATA

### 1. TERMS AND DEFINITIONS

Consent — the present consent of the User of the Site to the processing of personal data.

Operator — "ABF" Closed Joint-Stock Company, registered at the address: 26/1 Vazgen Sargsyan street, city Yerevan, state registration number 286.120.990481, TIN 02669436.

The User of the Site – the subject of personal data or (in case of incapacity of the subject of personal data) his/her legal representative who, by means of doing a number of actions of technical character in the appropriate part of the graphical user interface of the Site, provides the Operator with his/her own personal data or personal data of the represented person appropriately.

Request — an order of the User of the Site addressed to the Operator given by means of performing by the User of the Site a number of actions of technical character in the appropriate part of the graphical user interface of the Site

### 2. CONDITIONS TO WHICH THE USER OF THE SITE GIVES CONSENT

Hereby the User of the Site who entered a "tick" inside the checkbox in the appropriate part of the graphical user interface of the Site above the inscription "By entering a checkmark in this form, you give a consent to the processing of your personal data" freely, with his will and in his/her own interest provides the Operator with a specific, informed and conscious Consent on the following conditions:

The purpose of processing personal data: execution of the Request by the Operator, within the framework of which the User of the Site provides personal data.

The list of personal data for which the consent is given: the Consent is given by the User of the Site to the Operator for processing of those personal data which are provided by him/her when completing the fields of the Request.

The list of personal data processing operations to which the consent is given: collection, recording, systematization, acquisition, storage, refinement (updating, modification), extraction, use, depersonalization, blocking, deletion, destruction of personal data.

Generic description of the methods used by the Operator for processing personal data: manual processing of personal data, automatic processing of personal data, including the "Internet" network transmission and without the "Internet" network transmission, mixed processing of personal data.

### 3. PROCEDURE OF WITHDRAWAL OF THE CONSENT

The Consent is valid during 2018, may be withdrawn at any time through submitting an appropriate application by the User of the Site to the Operator at the e-mail box address: [Info@abf.am](mailto:Info@abf.am). The consent is considered as withdrawn within 7 (seven) working days from the date of receipt of the mentioned application by the Operator.
